## Course Description:

The course will advance your critical and evaluative skills in preparation for writing academic literature reviews required for your upgrade report and thesis. The course will be delivered through a lecture and workshop that form the base of further, recommended training in various referencing software and database/catalogue/online searching available through your specific institution. By the end of the course you will:

- Understand the kind of literature review you will be expected to write for a doctorate in the social sciences and its purpose in contributing to the originality of your research

**PLEASE NOTE:** In addition to attending these sessions, students are strongly encouraged to also attend training on **referencing software and database/catalogue/online resource searching** within their own institution (as this training needs to be delivered in an institutionally-specific way). Such sessions will:

- Be more able to obtain literature from a wide variety of academic databases and online sources, evaluate it effectively and show scholarly judgement over using it

#### **LECTURE: The literature review in academic research**

This introductory lecture will discuss different kinds of academic literature review and consider what distinguishes it from policy oriented literature review and commercial scoping exercises. The lecture will also reflect theoretically on the purpose of the literature review and its importance in contributing to the knowledge-base.
